VOTING DATES AND LOCATIONS

GENERAL VOTING will be open to qualified electors of the Village of New Denver on:

Saturday, October 15, 2022 between the hours of 8:00 am and 8:00 pm at the Knox Hall – 521 6th Avenue

ADVANCE VOTING will be available to qualified electors as follows:

Wednesday, October 5, 2022 between the hours of 8:00 am and 8:00 pm at the Village Office – 115 Slocan Avenue

ELECTOR REGISTRATION

If you are not on the list of electors, you may register at the time of voting by completing the required application form available at the voting place. To register you must meet the following qualifications:

- 18 years of age or older on general voting day
- Canadian citizen
- resident of BC for at least 6 months immediately preceding the day of registration
- resident of OR registered owner of real property in the Village of New Denver for at least 30 days immediately preceding the day of registration, and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election or otherwise disqualified by law.

To register, resident electors must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

To register, non-resident property electors must produce **2 pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from the other property owners.

MAIL BALLOT VOTING

As of June 17, 2021, all electors are eligible to vote by mail ballot.

REQUESTING A MAIL BALLOT PACKAGE:

Before 4 pm on October 13, 2022 you must submit the following information to the Village office in person (115 Slocan Avenue) by mail (PO Box 40, New Denver, BC VOG 1SO), fax (250-358-7251) or email (office@newdenver.ca):

- (1) Full name,
- (2) Residential address,
- (3) Address of the property in relation to which you are voting (for non-resident property electors),
- (4) Method of delivery of your mail ballot package:
 - pick up at Village office, OR
 - regular letter mail through Canada Post to residential address, OR
 - regular letter mail through Canada Post to an alternate address that you provide when requesting the ballot package, and
- (5) If you are not on the list of electors, to ensure you receive the correct registration application form in your package, you must indicate whether you are going to be registering as a resident or non-resident property elector.

The Village will send out mail ballot packages commencing on or about September 28, 2022. To be counted, your mail ballot must be received by the Chief Election Officer no later than 8 pm on Saturday, October 15, 2022.
