### BACKGROUND:

It has been many years since the Village's Policy Manual has been reviewed in its entirety and housekeeping is required. As circumstances (and governing legislation) change, some policies are no longer appropriate, some have been incorporated into bylaws or other documents, and some have been updated or replaced but the older versions were not formally repealed.
