The Village of New Denver is currently accepting applications for the following permanent full-time position:

UTILITY 2

ROLE:

Reporting to the Public Works Supervisor and the Chief Administrative Officer, this position plays a key role in safely constructing, improving and maintaining essential municipal services. The Utility 2 worker performs a variety of general and specific duties in relation to public works operations and programs, has excellent interpersonal and communication skills and the ability to deal with people in a professional manner, strong organizational skills, the ability to multi task, carries out work in accordance with established safe work procedures and has demonstrated physical strength, stamina and co-ordination to perform heavy manual outdoor work.

This is a unionized position, and preference will be given to qualified members in good standing of the International Union of Operating Engineers.

EXAMPLES OF WORK

- Garbage Collection;
- Operation of light and heavy trucks, light equipment and other related tools and equipment such as mowers, farm tractors, loaders, vibrating rollers, cement mixers, power saws, etc.;
- Operation of equipment, with attachments, such as trucks, loaders, backhoes, snowplows, sander, crawler tractors, garbage trucks, etc.;
- Installation, maintenance, operation and repair of roads, lanes and sidewalks, water and sewer systems, fire hydrants, garbage disposal areas, etc.;
- Performs minor repairs, greasing, oiling, minor servicing of the equipment involved and performs daily inspections of equipment operated to ensure safe and efficient operation;
- Maintenance of equipment, property, buildings and vehicles;
- Maintenance of parks, gardens, cemetery, etc;
- Cleans shops, yards, buildings, public facilities, parks and grounds, etc
- Other related duties as may be assigned from time to time;
- Maintains simple records including maintenance records.

NOTE: Utility 2 may be expected to undertake some training from the employer on equipment such as loaders, crawler tractors and backhoes and in such areas as snow removal, road repair, water and sewer systems and fire hydrants.

MINIMUM QUALIFICATIONS

- Valid B.C. Driver's Licence, Class 5, with air brake (Class 3 with air brake endorsement is desirable but not mandatory);
- Experience in a municipal or regional government setting;
- Water Operator Certification under BCWW Association Level 2;
- Physically fit.
