Background:

Quotations are requested for the work described below and as shown on the attached sketches and drawings (Attachment A-9 pages).

Purpose of the RFQ:

The purpose of this RFQ is to solicit quotations from qualified contractors for the works described herein. The Village intends to select and retain one contractor as a result of this RFQ.

RFQ Requirements:

Quotations shall include a brief schedule and bid price for the items set out in the tender form.

Note that the contractor submitting the proposal shall assume the responsibilities of Prime Contractor and therefore be responsible for coordinating overall site safety and the safety of any workers and sub-contractors.

All enquiries of a general nature shall be directed to the Village and enquiries of a technical nature regarding the project shall be directed to Dwain Boyer, P.Eng., SNT Geotechnical Ltd.

RFQ Evaluations:

Proposals will be evaluated by cost as well as proposed schedule.

The lowest price or any proposal may not necessarily be accepted.

After packages have been reviewed, the successful firm will be given a formal notice of award. The successful bidder will be required to provide the Village with the following documentation within ten (10) calendar days of receipt of Notice of Award.

- WCB clearance letter.
- Certificate of insurance, minimum \$2,000,000 CGL, naming the Village of New Denver as additional insured.
- Proof of valid Village of New Denver business licence or relevant inter-community business licence.
- Construction schedule.
- Company safety plan for the work being undertaken.

Reference Documents:

Attachment A - SNT Geotechnical Ltd Carpenter Creek Riprap Repair Site 'C' – Drawings for Construction,
November 2, 2022. Attachment A provides riprap size, gradation and riprap placement design sections
for Site 'C' and riprap size and gradation for Sites 'A' and 'B'. The actual location to place riprap at Sites
'A and 'B' will be as directed by the Village representative.

The Village in no way whatsoever represents, warrants, or guarantees that such data is complete, relevant, suitable, or representative or indicative of anticipated or actual conditions. Proponents remain solely responsible to independently investigate and satisfy themselves of actual site conditions.

General Notations:

During the term of the contract, any damage caused by the contractor to the property including but not limited to buildings, property surrounding buildings, surface fixtures which may include trees, shrubbery, fences or other outdoor appurtenances, or private vehicles will be the responsibility of the contractor. Every effort must be made to mitigate damage to areas surrounding the immediate work site.

The contract shall be subject to cancellation with written notice should the owner deem the service unsatisfactory for any reason.

Quotation:

Quotation for the individual work items is to be identified in Tables 1 & 2 below.

Payment will be made by the Village within 30 days of invoicing. Bi-weekly or monthly invoicing is acceptable.

Proposed lump sum pricing for this project shall include the following:

- All necessary Contractor project management roles and responsibilities, including general labor, assisting the Village in scheduling and coordinating subtrades, and safety and progress monitoring.
- All necessary site safety management of general workers, sub trade workers, inspectors, visitors, and all safety equipment.
- Supply and install of all materials specified herein, unless otherwise noted, including cost mark-up if applicable.

• All tools and equipment necessary to complete the construction project.

The construction work is as identified on the attached sketches and plan drawing. Site visits can be arranged with the Village.

Lump sum prices and itemized prices shall be submitted within the following section only. Hourly rates for general labor shall also be submitted within the following section only, for determining approx. values of any proposed/required force account work. The lump sum price and hourly labor rates shall be exclusive of applicable taxes.
