3. FORM OF TENDER

3.1 The project schedule and Milestone Dates listed in Appendix 2 – Construction Schedule have been revised. The Milestone Dates are now described as 'Village's target completion date, for reference'. These targets dates would enable the watermain construction and commissioning to occur in the Fall of 2023, but would allow the road repaving to occur in the Spring of 2024. In that situation, the Contractor would be required to temporarily finish the road surfacing with base gravel to ground level in the Fall of 2023 – and the Village would then maintain that gravelled surface through the Winter months.

Further, on the revised Appendix 2, the Contractor is required to provide actual construction dates that they will be able to achieve. Contractors do not have to propose to achieve the Village's target completion dates in order to submit a valid tender. As described in Contract Provisions section CP3 – Award, the Village will have consideration for the Contractor's proposed schedule when awarding this work. The Village will not necessarily Award to the lowest bid. Appendix 2 – Rev.1 is attached to this Addendum.
