2026 GENERAL LOCAL ELECTION**

PUBLIC NOTICE IS HEREBY GIVEN AS FOLLOWS:

ELECTOR REGISTRATION AND PROVINCIAL VOTERS LIST

The most current available Provincial list of voters prepared under the Election Act is deemed to be the register of resident electors for the Village of New Denver 52 days prior to general voting day.

The deadline to register with Elections BC for inclusion on the Provincial Voters List used for the election is Tuesday, August 18, 2026. Eligible resident electors who are not on the list may still register when voting.

Advance registration for non-resident property electors will be accepted at the Village of New Denver Office until 4:00 p.m. on Tuesday, August 25, 2026. Advance registration for non-resident property electors will not be accepted during the period of August 26, 2026 to October 18, 2026.

Eligible electors may register when voting.

LIST OF REGISTERED ELECTORS

Beginning Tuesday, September 1, 2026 until the close of general voting for the election on Saturday, October 17, 2026, a copy of the list of registered electors will be available for public inspection at the Village of New Denver Office, 115 Slocan Avenue in New Denver, during regular office hours.

An elector may request that personal information respecting the elector be omitted from or obscured on the list of registered electors.

An objection to the registration of a person as an elector may be made in accordance with the Local Government Act before 4:00 p.m. on Friday, September 11, 2026.
